## PRESIDENT'S MESSAGE

I hope that you were able to enjoy a peaceful and relaxing holiday season! The New Year is upon us as we prepare for the Spring 2003 semester. I wanted to update you briefly on the progress your Board of Directors have been making on their 2002-2003 Association goals. The FCPA Board of Directors held their Fall 2002 Board Meeting on August 18th and 19th at the Adam's Mark Hotel in Jacksonville. Some of the topics discussed included the yearly association goals, Conference 2004 planning, and the creation of a new association marketing brochure. Here is the update on the 2002-2003 Association Goals:

- 1. Increase Employer Membership On November 15th the Board conducted a special "membership" session in Orlando hosted by Chris Todd of Enterprise Rent-A-Car. Saranette Miles rolled out a three-part plan that we hope will help grow our current employer membership. This plan consisted of 1) reconnecting with former FCPA members to rejoin, 2) creating an Employer/Career Center representative team at as many campuses as possible to market FCPA to that schools top employers directly, and 3) trying to connect with Jacksonville employers during our Annual Conference.
- FCPA Budget During the Fall Board Meeting held on August 18-19th at the Jacksonville Adam's Mark the Board created a projected budget for 2002-2003, a zero-based budget. The specifics of this budget are covered on page 3 of this newsletter.
- 3. Create New Collateral to Reflect the New Image/Theme and Logo Change of the Association - Christy King put together a team of FCPA Board members and a local graphic artist to produce a new brochure and letterhead. The new brochure contains the new logo and verbiage "Keeping Florida First", as well as a diverse array of people.
- Plan and Present a Successful 2003 Annual Conference in Jacksonville, FL - Shannon Cash from FAU is the Conference Chair and he has assembled Conference Committees. If anyone is interested in getting involved they can contact Shannon directly at (561) 297-1003 or cash@fau.edu.
- 5. Offer "Added Value" to the Membership with Creative Benefits and Useful Tools - the Board discussed different ideas on how to add more value to being a member of FCPA. The Board agreed that the new FCPA website, www.fl-cpa.org, would be a good place to add these benefits like a resource page and links to conference exhibitors.

Please be sure to add the 2003 FCPA Annual Conference date, June 18th-20th, to your new calendar. Registration for this years conference will be made even easier through our website. As always, remember that FCPA is working to "Keep Florida First!!"

## Jacksonville, Florida June 18-20, 2003


