Highlights from the 2010 Business Meeting

We're not sure whether it was the eggs and coffee or the opportunity to second a motion, but everyone seemed to be up early and ready for our annual Business meeting when we were called to order at 8:22 am.

Each year, the president of FCPA sets goals for the board to accomplish in the coming year. Ray Rogers, now our past president, reviewed each of the goals, some of which included:

- A thorough review of our Constitution, which resulted in ten constitutional amendments being proposed, all of which will help to better reflect our organization's current status.
- Online membership renewal, albeit not without some technical difficulties, but we are on-target for the next renewal cycle since technical issues seem to have been resolved.
- Due to the leadership of our Professional Development Director, Mark Colvenbach, we offered additional educational programming during the year with a free webinar on combining the Strong & MBTI.
- Offering CEUs at our annual conference. Members can obtain CEUs through both NBCC and HRCI.
- We are now earning interest from the organization's reserve funds.

Speaking of funds... as of the Business meeting, our reserve sits at approximately \$38,000, of which, \$20,000 is in a short term CD, and \$10,000 is in a money market account.

Druing the Information Management Director's report, Eric Hall reminded us to let him know about career fair dates so he can post on our website. Additionally, he let everyone know that because of the website redesign, members can now update their own record/contact information. New members should be sure to indicate who referred them so that the referring member will be eligible for a great prize.

Membership numbers in FCPA fell in 2010, from a total of 251 in 2009 to 191 in June, 2010. There was a decline in all membership categories over the past year. Our decline in membership numbers over the past couple of years mirrors that



of the nation's economic decline, so although it is not surprising, we will continue to work towards growth.

He helped lead the Association through some rough financial times and was the voice of reason during many heated debates and discussions. Jane Colson Remembered at FCPA

Jane lost her battle with breast cancer in early June, just a couple of weeks before the opening of the FCPA conference. Pink ribbons and pictures of Jane were passed out to members in what was hoped to be a positive way to remember and honor one of FCPA's most dedicated supporters.

Ray Rogers, president of FCPA, and Tim Harding, representing the Colleges of Central Florida Career Consortium, each spoke to the membership about Jane's contributions and friendship in what became a very emotional moment for everyone in the room. "For those of you who knew Jane Colson, you know how much she hated public attention and being in the spotlight... and would know how uncomfortable she would be if she knew we were again honoring her in such a public way." said Ray as he began his prepared comments for the evening. "For those of you who didn't know Jane well, know that she embodied the heart and spirit of FCPA. Jane never missed an annual conference and this President's Reception was always a highlight for her."

During her 7-year involvement in FCPA, Jane served twice as the conference program chair, served as logistics chair in 2007 and chaired the exhibitors committee in 2008. Jane also served as President of the Colleges of Central Florida Career Consortium, served as the 2007-2008 chair of the Tampa Bay Beaches Chamber of Commerce Board and was a member of the Madeira Beach Planning Commission from 2003 until 2005. She was recognized in 2006 by Soroptimist International, an organization of professional women dedicated to enhancing the lives of women and girls. Most of



all, Jane was loved by her students at Eckerd College and played a vital role at that campus since 1989, starting as an administrative assistant in Eckerd's Development Office, eventually becoming the Director of their Career Center in 2005.

For these and so many other reasons, at last year's conference, FCPA presented Jane Colson with its highest honor, the Brownlee Leadership Award. Those who were in attendance at last year's Awards Luncheon, saw just how surprised but honored Jane was to have received this recognition.

In honor of Jane, both, FCPA and the Colleges of Central Florida Career Consortium, donated over \$1,000 to organizations identified by Jane's husband, Suncoast Hospice and the Susan G. Komen for the Cure Foundation.

In loving memory of Jane, the evening ended in a formal toast to one of the association's bright lights whose contributions and friendship we will always cherish.

2010 FCPA Annual Conference Evaluation Update

A preliminary review of the conference evaluation shows that this year's attendees greatly enjoyed this year's events. Attendees included representatives from 19 colleges/universities and 8 employers/ exhibitors. At this time we have a 60% response rate (50 out of 82 attendees).

The feedback collected from the survey will be reviewed by the Board of Directors and Conference Committee members. It will also be passed on to Amy Diepenbrock as she leads next year's conference committee on planning the 2011 FCPA Conference in Clearwater Beach. Below is a summary of the survey results.

The overall conference was rated either Excellent or Very Good by 72% of respondents (an average of 4.5 on a 5-point scale), while the Newport Beach Resort and Spa, this year's conference location, received an average rating of 3.22 (out of 5.0).

We received positive reponses on the addition of CEU sessions (NBCC and HRCI) with 57.1% of respondents indicating that they attended at least one of the CEU sessions and 14% indicating that these sessions affected their decision to attend the conference.

The breakout sessions received an average of a 3.90 with the top breakout session being the "Immigration 101: What Happens When I Want to Hire an International Candidate?". The next two highest rated sessions included "Where the Jobs Are: The Key to Federal Employment" (4.36) and "Shining Light on Career Development for Special Populations" (4.30).

The meals, receptions and special events all received positive ratings. The three top-rated events were the President's Reception (4.27), the Banquet (4.28) and the Awards Luncheon (4.18). The new Roundtable initiative was very well and received an average rating of 4.11 and were thought to be some of the most effective or useful areas of programming for this year's event. The two leading roundtable topics were a tie between "Social Media Sites" and "Teaching Students Professionalism".

Most of the survey respondents reported having met their goals for the conference, some of which included professional development, networking, learning about best practices and reconnecting with colleagues from across the state.

Respondents provided a few suggestions for next year's conference, including adding another roundtable session, having additional recreation events and adding a one-day conference registration option.

The overall event was well received and many shared comments how good the quality of the event was, including comments on the relevancy and usefulness of the breakout sessions. Kudos were also given to the planning committee by many respondents for a job well done.

We look forward to seeing you in Clearwater next year!

Shining the Light on Career Development for Special Populations:

A Personal Perspective

I was recently given the opportunity to present at my first professional conference. This article will focus on my impressions of that experience. I have been a Career Coach with the office of Career Services at Florida international University (FIU) for the past 14 months. I was asked if I would be interested in submitting a presentation to be considered for Continuing Education Unit credit at the Florida Career Professionals Association (FCPA) Annual Conference. At first I was intimidated with the idea of giving my first professional presentation. However, after careful consideration I decided to take on the challenge.

The single biggest challenge for me was to condense 14 months of work into a 45-minute presentation. However, after stripping it down I decided to approach my presentation from both an academic and personal point of view. In consultation with my colleagues and bosses I came up with the title "Shining the Light on Career Development for Special Populations." I strongly believe that this title reflected exactly what I've been working on for the past 14 months. It was also an opportunity to represent a perspective that doesn't often get showcased. The disability community often gets overlooked with very little emphasis being placed on their individual needs as well as their abilities. I also took the opportunity in my presentation to discuss the basic principles of the Americans with Disabilities Act (the ADA) and many myths and facts regarding employment of people with disabilities. My presentation also addressed what I believe are the essential ingredients for being an effective career coach for this specific targeted population. This presentation resonated with me on two levels – (1) as a new professional I was honored to be selected to present at this statewide conference and for my presentation to be approved as a CEU by the National Board of Certified Counselors; and (2) as a person with a disability to represent the community that I am so passionate about helping.

It is because of my own personal struggle as a black man with a physical limitation and the fact that it took me two years after receiving my Master's Degree from FIU to become employed, that I can identify with the plight of this population. It is a positive step in my opinion for the FCPA to have the foresight to want to address issues that this special population faces in striving for inclusion and success.

After this presentation I realized that I was given a unique opportunity to present to both new professionals as well as seasoned veterans in the career development arena. I considered this unique because I am a person with a disability presenting on issues related to people with disabilities. It was the culmination of a dream for me to present on this topic for a couple of reasons: 1) disability issues are often not addressed in the professional arena; and 2) as a person with a disability myself, this was an opportunity to illustrate the obstacles that we face daily and for me to address these issues in a clear and concise way.

It is my sincere belief that anyone who is privileged to work in an environment where there is an opportunity for professional and personal growth, that's when your best work is done. \checkmark
